BOOKING AMENDMENTS: All amendments to bookings are subject to availability of vehicle and/or package. Different rates may apply based on the amendment made.

ONE-WAY RENTALS (MINIMUM 7 DAY RENTAL REQUIRED)

- One-way rentals are available between all Maui branch locations . the exception is one-way rentals into or out of Tasmania for 4WD vehicles, these are on request.
- Minimum rental period for one-way hires is 7 days. Shorter hires may be available on application only.
- A one-way fee of \$250 applies where pick up originates from Cairns, Brisbane, Sydney, Melbourne, Hobart or Adelaide, and returns to these locations. Should the hire originate or return to or from Darwin, Broome, Alice Springs or Perth, the one-way fee will be \$350.

RENTALS IN BROOME

An additional remote location fee of \$650 applies to all rentals picking up or dropping off (or both) in Broome. Only one remote location fee is charged per vehicle. This is in addition to the One-Way fee if applicable.

AIRPORT CONCESSION FEE

An airport concession fee may be charged for hires with pick up or drop off from Airport locations. An Airport pick up fee AUD\$16.50 per hire will apply for hires with pick up at Hobart Airport. The Fee is subject to change and new airport charges may apply.

FOR YOUR PROTECTION

Personal Injury is covered in most cases through Registration Third Party Insurance. We strongly recommend that all people travelling in Australia take out Personal Travel Insurance.

All vehicles are insured for the damage to the vehicle or to the property of a Third Party. The hirer is responsible for the first AU\$ 7,500 (the excess) of the cost of damage to Third Party property or to the rented vehicle, including single vehicle accident, windscreen and tyre damage, overhead and underbody damage, towing and recovery costs, theft, fire, break-in, vandalism. This also includes the cost of the daily rental for the period the vehicle is off fleet for accident repairs). The excess applies in respect of each claim not rental.

This AUD\$7,500 excess can be reduced, in most circumstances, by the purchase of Excess Reduction Option 1 or Excess Reduction Option 2.

No Worries Cover Option (PCO2)

The no worries cover option is only available when excess reduction 2 has been purchased.

Note the no worries cover option is included in the Maui Premium package.

The no worries cover option extends the cover available with excessreduction 2 to include cover for accidental damage to the overhead and underbody sections of the motorhome. Please note overhead and underhead damage cover is excluded unless the no worries cover option has been purchased.

EXCLUSIONS

Any water related damage which includes but is not limited to:

- Any vehicle submersion
- Creek or river crossing
- Driving through low plain flooded areas
- Beach driving
- Personal belongings

All excess reduction is void if the terms of the rental agreement are breached. The hirer will be responsible for the total cost of any damage. This will also include any damage caused by willful misconduct (eg sitting or standing on the bonnet or the roof of the vehicle) and driving under the influence of alcohol or drugs.

The incorrect use of fuel(fuel being diesel or petrol) The hirer will be responsible for any associated cost. The cost to retrieve or recover a vehicle which has become bogged, regardless of the excess reduction package taken. The cost to replace keys

which have become lost, or retrieval of keys which have been locked in the vehicle. Overhead and underbody damage to the vehicle. All Excess Reduction is void if the terms of the Rental Agreement are breached.

VEHICLE SECURITY DEPOSIT

On pick up of the vehicle, a Vehicle Security Deposit is payable. The amount is determined by the Protection Package selected.

AUD\$7500 - If no Excess Reduction is taken
AUD\$2500 - If Excess Reduction Option 1 is taken
AUD\$220 - If Excess Reduction Option 2 is taken (for 2WD)
AUD\$440 - If Excess Reduction Option 2 is taken (for 4WD)

The Security Deposit is fully refundable provided the vehicle is returned on time, to the correct location, undamaged, with a clean interior and with full fuel tank.

We reserve the right to retain a AU\$220.00 soiling fee if the vehicle is not returned with the interior in a clean condition and 4WD vehicle free of mud. The toilet and waste water tank (if applicable) must be emptied prior to the return of the vehicle, or an additional AU\$125.00 soiling fee will be retained.

INFRINGEMENTS:

We reserve the right to charge the hirer for any speeding, parking or toll-way fine, associated administration cost and or accidents including third party property damage not reported on return of the vehicle. The administration fee per fine will be AU\$60.00.

PERSONAL AND COMPANY CHEQUES

Personal and Company cheques will not be accepted as payment for rentals at the time of pick-up. These must be received by Maui 14 days prior to commencement of rentals. Personal or Company cheques are not acceptable as the vehicle security deposit.

CREDIT CARDS

The credit card holder will be jointly and severally liable as a customer. Accepted credit cards are Visa, MasterCard and America Express. A non-refundable 2 % administration fee will apply to all Visa and MasterCard transactions and 4.5% to America Express cards, Credit Card administration fees also apply to debited security bonds and only the hirer's credit card is acceptable to use for the purpose of the security bond.

LICENCE DETAILS FOR THE "SEE AUSTRALIA" PROGRAMS ONLY

A full Australian drivers licence, held for a least one year, is to be presented at the time of rental.

LICENCE DETAILS FOR THE "STANDARD" PROGRAM ONLY

A current and full motor vehicle licence, held for a least one year, is to be presented at the time of rental. If a licence is not in an English format, an international drivers licence is also required alternatively an accredited English translation will be accepted in lieu of an international driving permit.

AGE RESTRICTIONS

Drivers must be 21 years of age or over. A medical certificate stating that the customer is fit to drive the vehicle they have booked for the duration of the hire is required for drivers over the age of 75.

CHANGE OF DROP-OFF DESTINATION

If the hirer wishes to change the drop-off destination after the Rental has commenced, they must first obtain authorisation from the destination branch. Subject to the change being approved, an additional charge of up to AU\$550 may apply.

ROAD RESTRICTIONS

Motorhomes can only be driven on sealed/bitumen roads. The only exceptions to this are well maintained access roads to recognised campgrounds and the grounds on Kangaroo Island (S.A) Maui reserves the right at its sole discretion to restrict vehicle movements in certain areas due to adverse road or weather conditions, and the distance to nominated destinations in relation to the length of the hire period.

CUSTOMER CARE ON-ROAD ASSISTANCE

Any problems associated with the vehicle, including equipment failure, must be reported to Maui as soon as possible, and within 24 hours in order to give Maui the opportunity to rectify the problem during the rental. Failure to do so will compromise any claims for compensation. Maui does not accept liability for any claims submitted after this period.

REPAIRS

Repairs up to AU\$200 may be effected without authorisation and will be reimbursed. For amounts over AU\$200 Maui will need to be informed in advance. Repairs will be approved provided the hirer was not directly responsible for the damage. Receipts must be submitted for any repair or the claim will not be paid.

CHANGE OF VEHICLE

Should the vehicle booked be unavailable through unforeseen circumstances, Maui reserve the right to substitute an alternative vehicle without prior notification and at no extra cost. This shall not constitute a breach of contract and

does not entitle the hirer to a refund.

IMPORTANT: Maui reserves the right to refuse any rental at its discretion.

ANIMALS: No animals are permitted in our vehicles, excluding guide dogs.

Please pick up your vehicle from the depot shown above.

On collecting your vehicle, you will be given a contract to read and sign. Ensure that you are aware of the conditions of this contract, including additional charges not covered by your documentation, insurance conditions and options, driver responsibilities. In particular please note the following:

MANDATORY CHARGES PAYABLE DIRECT:

Vehicle security deposit, late return charges, after hour surcharge, one way rental charges (if applicable)
Other mandatory charges may apply to your booking and details are available on application with Maui direct.

Security Deposit: Upon collection, a security deposit is required amount is determined by the excess reduction option selected. For security purposes, ONLY A CREDIT CARD can be used to provide a vehicle security deposit. The credit card holder must be present and able to sign upon collection. The card holder is jointly liable for any damage to the rental vehicle.

Vehicle Insurance Excess:The hirer is responsible for the first AU\$7500 ("the excess") of the cost of damage to third party property or to the rented vehicle. This AU\$7500 can be reduced, in most circumstances, by the purchase of excess reduction options. Debited bonds are subject to a 2% credit card administration fee in addition to the bond amount when the credit card used is either a Visa or MasterCard and 4.5% when the credit card is American Express.

Excess Reduction option 1: Security Deposit AU\$2500, Insurance Excess AU\$2500

Excess Reduction option 2: Security Deposit AU\$220, Insurance Excess AU\$NIL

TRANSFERS:

The customer's taxi fare from the airport to Maui branch is refunded upon vehicle collection only. Receipt must be presented for re-imbursment. All other transfers are at customers own expense.

DRIVERS LICENCE REQUIREMENTS:

A current and full motor driver's licence is required and must be produced upon vehicle collection. Should a foreign licence be in a language other than English it must be accompanied by a correct international driving permit issued in the same country as the driver's licence was issued. An accredited English translation will be accepted in lieu of an international driving permit.

RENTAL PERIOD:

Rental days are charges per calender day. When calculating the number of days a vehicle is rented, the day of pick-up is counted as day one of the rental and the return day is counted and considered the final day.

*Minimum Rental Period: 5 days for Spirit 2 Grande, Spirit 2T/S,
Spirit 4WD and 7 days for Spirit 4 and Spirit 6

*All one-way hires are subject to a minimum 7 day hire requirement.

*A 7 day minimum applies to all hires with a collection date between 15 December and 5 January.

*Minimum rental periods are subject to change during peak periods.

*Late pick up or early return of vehicle does not entitle the hirer to any refund of the unused portion of the rental.

*Late returns will be charged on a per day basis. Failure to obtain authorisation for a rental extension will result in a daily rental fee of AUD\$150 in addition to the daily rate.
