AGENCY LOCATION SURCHARGES Kerikeri is classified as an "Agency" location and has a location surcharge of NZ\$45 plus GST for each rental initiated.	All drivers must be a minimum of 21 years and have a valid National driving licence, held for at least one year. This must be presented at the renting location at the commencement of the rental. There is no charge for additional drivers. For group M drivers must be 25 years and over and have a valid national driving licence, held for at least one year. <b>ADDITIONAL DRIVERS</b> Additional drivers are free of charge.
